Motion by Mr. Sowcik sec Mr. Drust requesting the Civil Service Commission to conduct test for the position of full time police officer. Motion carried.

Mr. Sowcik said we received our 2007 Ford Explorer. Commended police officers Byczek and Bonawits on their actions on apprehending the suspect at the Hilltop Apartments. Suspect was disarmed without anyone being injured. Mr. Sowcik stated the borough is very tough on crime and has been working to reorganize the police department.
